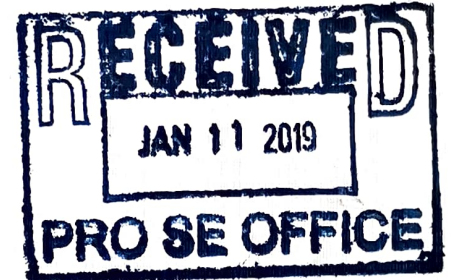

2. Case # 16-cv-2218(FB)(SMG- ROSELYN ISIGI against HARRY DORVILIER and HARRY'S NURSES REGISTRY.
3. Case # 17-cv-06350 -MARJORIE MCFARLANE, VELMA PALMER, and CLAIRE WILLIAMS vs. HARRY NURSES REGISTRY, HARRY HOME CARE INC. , AND HARRY DORVILIER.



4. The case of the FLSA action lawsuit was wrongly decided, and was wrongly persecuted by the Queens District Attorney's Office and the State Insurance Board. The law explained that only the Department of Labor and the Internal Revenue Services (IRS) are the only two agencies who have the jurisdiction to persecute an employer for misclassification of worker.

In conclusion both Mr. Bernstein and the Court are fully responsible for the malicious persecutions from the Workers Compensation Board and the District Attorney Office.

In fact if the nurses are Independent Contractors or employees, Harry's Nurses Registry pays over 1 million dollars for Workmans' Compensation (see the cancel checks on line). Harry Dorvilier and Harry's Nurses Registry Inc. were convicted for grand larceny and paid \$24,531.00 to the nurses, \$26,000.00 for fine for Harry Dorvilier, and \$26,000.00 for Harry's Nurses Registry Inc. I would like these convictions to be reversed by the State Court. All of these harassments

were orchestrated by Mr. Bernstein, and all the other Judges who were involved in the decisions (08/2006-11/2007.)
