Re: <u>Isigi v. Harry's Nurses Registry, Inc. and Harry Dorvilier</u> Civil Action No. 16 Civ. 2218 (FB)(SMG) Plaintiff's Pending Motion for a Turnover Order Has Been Rendered Moot and Plaintiff's Request for the Court to Issue an Order of Satisfaction of Judgment

Dear Judge Block:

Our firm represents the Plaintiff Roselyn Isigi in the above-referenced action. On January 11, 2021, Plaintiff filed a motion with this Court seeking an Order pursuant to N.Y. C.P.L.R. § 5225(b) and Fed. R. Civ. P. 69(a), directing Bank of America, as garnishee, to turnover funds from Defendants' account to satisfy the judgment entered by this Court on November 13, 2020 to the firm of Meenan & Associates, LLC (hereinafter "M&A"), as counsel for Plaintiff in this matter. [Dkt #s 110-113]. I write the instant letter to advise the Court that Plaintiff's application for a turnover order has since been rendered moot. After being served with Plaintiff's motion papers, Bank of America recently issued a Cashier's Check to M&A for \$26,671.35, which represents the amount of the judgment. (A copy of the January 26, 2021 letter from Bank of America and a copy of the Cashier's Check are annexed hereto as **Exhibit "1"**); [see also, Dkt # 109 (judgment)].

The Court has set a deadline of February 12, 2021 by which the Defendants shall serve and file any opposition to Plaintiff's motion for a turnover order. However, given Bank of America has released the funds to satisfy the judgment entered against the Defendants, we respectfully ask that Plaintiff's motion for a turnover order be discontinued.

Pursuant to Fed. R. Civ. P. 60(b)(5), the issuance of funds by Bank of America renders the judgment at issue satisfied. E.D.N.Y. Local Civil Rule 54.3 (d) provides that satisfaction of a money judgment entered in this District shall be entered by the Clerk pursuant to an order of satisfaction entered by the Court. Accordingly, we request that the Court issue an order of satisfaction pursuant to E.D.N.Y. Local Civil Rule 54.3 (d), and direct that said order be entered by the Clerk of this Court.

We thank the Court for its consideration and courtesies.
